Harbor Dish's mission is to increase food security while strengthening community. The nonprofit strives to help children and families be at their best by serving healthy and delicious meals accessible to

them best by serving hearty and delicious meals accessible to everyone in the community following the pay-what-you-can model they of the “One World, Everybody Eats” community cafes. These cafes increase food security while reducing food waste, and foster diversity, equity, inclusion and family well-being. They create spaces where people are nourished physically, emotionally and spiritually by bringing together diners from all walks of life and creating connections between participants. Harbor Dish is the only community cafe in Florida region modeled after the One World, Everybody Eats network.

Harbor Dish presently serves 50 pay-what-you-can dinners weekly on Safety Harbor's Main Street and an additional 100 dinners at the monthly community street celebration. Additionally, Harbor Dish prepares and donates 100-150 meals weekly to domestic abuse survivors at Community Action Stops Abuse (CASA) in St. Petersburg, foster children and ESOL (English for Speakers of Other Languages) classes at the Mattie Williams Neighborhood Family Center. Harbor Dish also prepares meals for the students at Safety Harbor Middle School once a month and additionally prepares meals at most Safety Harbor city and family events, Safety Harbor Museum events, and Folly Farm Preserve events.

Harbor Dish relies on financial as well as food donations from our many wonderful community partners, including Whole Foods, Panera Bread, Nature's Food Patch, Olive Garden and Carrabba's. Food donations from these companies that are not being used immediately for our meal preparations are donated by Harbor Dish to other nonprofits that serve domestic abuse survivors, foster children and low-income families.

Food insecurity affects 800 million people globally, including more than 14% of Pinellas County residents. Harbor Dish addresses both food security and family well-being by providing nutritious, restaurant-quality food to all. We are supporting community well-being one meal at a time!

**Grant Purpose (one paragraph)**

Since the Covid-19 pandemic began, Harbor Dish has quadrupled the amount of food it receives and distributes to 227,346 pounds last year. This grant would allow Harbor Dish to sustain and expand the mobile community cafe with the purchase of a 10-foot food trailer. Harbor Dish does not have a brick-and-mortar location and is entirely mobile. A trailer would allow the meals, which are cooked in a rented church space, to be kept hot/cold during transport and while serving. Presently, food is transported in food pans and stacked near portable tables for distribution. A trailer would allow us to use warming equipment and a refrigerator, increasing flexibility in food storage and allowing meal service through a window under an awning. The purchase of a trailer would also allow Harbor Dish to expand capacity by preparing and transporting a larger quantity of meals, while expanding geographical outreach. This need is more important now than ever as we are seeing an increase in the number of families becoming food insecure due to increasing food and fuel costs. In addition to increasing our capacity to serve and streamlining outreach, a trailer would also give the ability to mobilize a generator for use during natural disasters or other humanitarian emergencies. A trailer would allow us to mobilize quickly to serve victims of disasters and first responders. A nourishing meal in a time of crisis is much more than a plate of food—it's comfort, hope and dignity. If awarded this grant, the remainder of the project budget will be covered by grants from other foundations, corporations and community organizations as well as individual donations.

## **2. Case Statement**

The mission of Harbor Dish is to increase food security and build community. Following the model of the One World Everybody Eats (OWEE) network of community cafes, all are welcome to dine together in dignity, regardless of means. Healthy and delicious meals are served to people from all walks of life, fostering not only food security but an interconnected community of compassion, diversity and inclusion. These cafes provide an innovative way to address food insecurity while reducing food waste and bringing people together. Harbor Dish serves meals to the community every Friday, in which patrons pay nothing or whatever they can, or pay it forward for others. Each week we also provide meals to domestic abuse survivors, foster children and ESOL (English for Speakers of Other Languages) students. Harbor Dish participates in Third Friday events in Safety Harbor and also provides food for city and other community events. Food is delivered weekly to homebound seniors, and excess food is donated daily to other nonprofits that serve low income families and homeless residents. Last year Harbor Dish handled 227,346 pounds of food and helped to build community by bringing people together to share a meal. Recently, we have been asked to provide food services to Bay's End Manor Mobile Home Community during emergencies like a tornado or hurricane. In August, we will also begin a Monday night meal at Folley Farms. We have five volunteer chefs with restaurant experience, in addition to many other volunteers that take the donated food and turn it into delicious meals. We track our success by keeping data on the amount of food we receive, and by the number of meals we serve.
