Providing non-medical, financial assistance to adults undergoing cancer treatment in Florida to allow them to focus on fighting cancer.

A cancer diagnosis can change everything. For some, it may mean the added stress of financial hardship. The Florida Cancer Specialists (FCS) Foundation provides financial support to qualified adult cancer patients in the state of Florida for expenses such as rent or mortgage, car payments and car insurance, and utility bills. By giving patients peace of mind in knowing that their bills are being paid while they are undergoing treatment, the FCS Foundation allows them to concentrate on what really matters – fighting cancer.

Due to the generosity of the Florida Cancer Specialists physicians in covering all overhead expenses for the Foundation, 100% of donations received go directly towards paying the essential non-medical living expenses of an adult battling cancer.

Grant Purpose (one paragraph)

Each qualified applicant will receive a maximum of \$2,000 per calendar year to assist them in paying non-medical, essential living expenses. The Florida Cancer Specialists reviews applications and once an applicant is determined to meet our eligibility requirements (Be 18 years old or older, currently receiving cancer treatment, having an annual household income at or below 200% of the Federal Poverty Guidelines, having less than \$5,000 in total household liquid assets (checking, savings, CD, stocks etc.), complete an online application and submit all required support documentation) they will be awarded the grant. The FCS Foundation then works with the patient to pay the bills they select directly. The FCS Foundation will issue checks directly to landlords, banks, utility companies etc. to ensure the bills are paid timely. This grant would allow us to assist 10 additional patients for 2022. In the 10 year history of the FCS Foundation, no qualified applicant has been turned away and your gift can help ensure we can continue to help more cancer patients in need. Your gift will help us help cancer patients keep a roof over their head, the lights on and a way to get to their treatment.
