Please provide us with a brief description of your organization (no more than 500 words).

My family founded our organization in 2022 to honor the life of my oldest son, Scott. Scott struggled with schizophrenia for 10 years before dying by suicide in February 2020. Our mission is to educate the youth, parents, law enforcement and the general public by having open dialogue about mental illness. We are currently working with youth community centers, recreation departments, and schools to offer programs to the youth to teach them about mental health and how to talk about it. We also offer town hall discussions with parents to learn about their concerns and suggestions. Dawn works with Law Enforcement to share Scott's experience with LEO and how important it is that all officers and dispatchers are Crisis Intervention Team trained in order to learn how to interact with someone in a mental health crisis. We also started the first Surviving a Suicide Support Group in north county and continue to be a resource for people who have lost someone to suicide. We continue to think of unique ways to offer programs to remove the stigma of mental illness and suicide. We work closely with other organizations (NAMI, JWB, and others) and advocate to our delegates for the importance of increasing resources for mental health and suicide prevention. We may be starting out small but will continue to grow to bring awareness about the importance of teaching about mental health, removing the stigma, teaching others how to talk about it and what to do if someone needs help.

Grant Purpose (one paragraph)

We will be working with Mattie Williams Neighborhood Center during their summer camp session. We will be offering youth wellness programs to be added to their summer curriculum. These services will include sessions for mental health activities (journaling, art, activity books, how to understand your feelings, etc.), drumming, meditation/yoga, financial basics for the older children, and reading activities. This grant would be used to purchase books that focus on mental health issues that affect our youth today. The younger children will each receive a book on bullying and how to work together that was written by a local author and the older children will each receive a book on self-esteem, understanding feelings, and the importance of mental wellness. If we are able to receive the full grant, we will also offer this at another youth community center.

Speak Up, Let's Talk About Mental Health would like to submit a proposal for a \$8000 grant for the purpose of providing mental health educational programs at four 2024 summer camps in North Pinellas County. These programs will include a full curriculum of mental health activities that will include yoga for youth, interactive activities and discussions, nutrition, cardio- drumming, creating a library with books specific to understanding the importance of emotional well-being, providing the youth with books to read at home and a beginning financial program for middle school age students. We would also provide scholarships for the students that can't afford the field trips that are taken at the camps. By not being able to participate in the field trips, the youth feel left out from participating in programs that the other campers are able to go to.

Our mission is to provide education on mental illness and suicide prevention in addition to removing the stigma of mental illness and suicide by working with youth, parents, community, and law enforcement officers. When working with youth we address all aspects of mental health to include emotional, social, physical, financial, and nutritional.

Our grant request aligns with The White Family Foundation's vision of bringing positive changes to people's lives and enhancing the community which we live in by supporting local education and healthcare.

This grant will impact our community by educating our youth, as young as the age of five, to understand their feelings, how to ask for help, what empathy means, how to respect others and much more. We will work with our youth to give them coping skills to use throughout their lives. We will work to decrease the stigma of mental health in the effort to lower the increasing number of youth suicides and to provide resources for people that are seeking help.

Case Statement

Who we are:

Speak Up: Let's Talk About Mental Health, Inc. is a nonprofit that was founded in May 2022. We started our organization to honor my oldest son's life and create a purposeful legacy for him. Scott was an amazing young man, who had the entire world in front of him until he was diagnosed with schizophrenia at the age of 23. Scott and our family were thrown into the mental healthcare system, which was and is broken. After struggling with his illness for ten years, Scott died by suicide in February 2020. I also lost a sister-in-law to suicide in August 2022 after she struggled for many years with an undiagnosed mental illness. After Scott died, our family knew we needed to have a purpose and that was to make a change in the mental health care in our community. We wanted to ensure that funds we raised would go directly back to our local community, particularly North Pinellas County. We are dedicated to giving hope to those struggling with a mental illness, their families and to others that have been affected by suicide. Our mission is to educate and bring awareness about mental illness and suicide, to remove the stigma of both, and to be a resource for people who have lost someone to suicide.

What we do:

We work with local community centers, schools, city recreation departments, and colleges to offer programs on mental health and suicide awareness. We also work with law enforcement officers by participating in the Crisis Intervention Team Training to educate them on how to interact with someone in a mental health crisis. We partner with NAMI-Pinellas and JWB by participating in the events and programs they offer. We also collaborate with many other groups and individuals to speak at community events, town hall meetings; wherever we can speak and educate about mental health. Even though we are a newer nonprofit, we are proud of the accomplishments we have made in the last year and the upcoming programs we have. We are making an impact. The accomplishments we have made in our first year:

- Holding an open town hall meeting in Safety Harbor with parents and students to discuss what they feel we can do as a community to help bring awareness and education to our citizens. We are now working on a plan to roll out the suggestions to the city.
- I personally have presented the NAMI Programs Ending the Silence and In Our Own Voice to students at SPC-Tarpon Springs Campus, at a Safety Harbor townhall meeting, and to a few large employer groups in the area.
- I participate every other month in the Pinellas County Sheriff's Crisis Intervention Team Training by sharing my story about Scott and our family to educate them on how to interact with a person in a mental health crisis.
- We started the first Surviving a Suicide Loss Support Group in North Pinellas.
 There was a huge need for a support group in this area and we facilitate monthly meetings in Dunedin. There is an average of 15 people at each meeting with at least two new attendees each month. We started this in January of 2022.
- We designed and printed a trifold that has resources for people who have lost someone to suicide. We distribute them to local law enforcement so they can leave them with family members at the scene of a suicide.
- We hold "pop-up" events at local businesses to raise awareness about our organization and have resources available for people that need assistance.

These also serve as mini-fundraisers, and we have had success with these events. Many people are not aware of the resources that are available to them, both as family member and as a person with a mental illness. We have been able to provide these resources for the people in need.

- We have two annual larger fundraising events each year. The funds from each of these events is designated for a specific cause (i.e., youth programs, Veteran's programs, First Responder's, Police Officers', sponsorships for youth, etc.).
- I have gone to the State Capital and advocated to our local representatives about the importance of increasing the funding for mental health programs in our state.
- I also presented at the International Crisis Intervention Team Conference in Pittsburg last year and will be presenting again this year in Detroit. The topic was the importance of the CIT training and how as family members we can make a change in how officers interact with someone in a mental health crisis. This interaction can make a difference in the outcome of the situation. The expenses are paid for by the International Crisis Intervention Organization.
- I presented at the NAMI-Florida Conference last year and will also be presenting again this year in September 2023. This topic will be on working with your local CIT organization and how to become involved in their training. Since I am a presenter, the expenses are paid for by NAMI.
- During the summer of 2023, Speak Up will be partnering with three local youth summer camps to provide mental health activities in their summer curriculum. We are working with Mattie Williams Family Neighborhood Center in Safety Harbor; Union Academy in Tarpon Springs and Cops n Kids in Tarpons Springs. We will be providing mental health activities, gratitude journals, creating a library at each of the locations that will focus on bullying, working together, respecting others, building self-esteem, etc., yoga for youth to teach them how to handle triggers, cardio drumming, having a local author come in and read his book on bullying and give each child a personalized copy, and a basic financial class for 6th-8th graders. We will also be purchasing Buddy Benches for their playgrounds. Each of the students will also receive a backpack with their own book and other items for them to use. We will be impacting close to 300 youth with this program.
- We will also be working with the teen counselors at Safety Harbor's Summer Recreation Camp. We will be teaching how to know the signs that someone may being feeling depressed, anxious, or simply need someone to talk to. We will educate them on the words to use during the conversation and when to let an adult know.
- We also nominated a youth for the 2023 Hershey Heartwarming Young Heroes
 Grant for her program, "I Am Enough." Her classmates and her have purchased
 books that focus on acceptance, self-confidence, how to work through change,
 and how to achieve your goals. These books will be distributed to a lower
 income community center so that each child will have a book to read.

• The "Problem"

United States Facts:

- 1 in 4 Americans have a mental illness.
- 1 in 6 American Youth, between the ages of 6-17 experience a serious mental illness each year.
- 30% of middle and high school students reported that within the past year have felt sad or hopeless for two or more weeks in a row. This statistic is up 9 % from 2019.
- Suicide is the 2nd leading cause of death among people between the ages of 10-14. It is the 3rd leading cause among people between the ages of 15-24.

Florida and Pinellas County Facts:

- 180,000 Floridians ages 12-17 have depression.
- High School Students with depression are more than 2x likely to drop out of school than their peers.
- 35 Middle School and High School students have died by suicide in the past three years.
- Pinellas County has the HIGHEST suicide rates compared to other large counties, such as Broward, Hillsborough and Miami-Dade.
- 25% of surveyed Pinellas high school students reported having seriously thought about killing themselves in a 2017 Youth Health Survey. These numbers are increasing.

Youth today are not taught about mental health, mental illness, or suicide awareness. High school students have a 6-hour class taught once through their four years at school and the topics are limited, due to laws that prevent educators from talking about sexual orientation and suicide. We must talk about these topics so the stigma of mental illness and suicide can be reduced and ultimately non-existent. Due to the stigma, youth as well as adults are hesitant to ask for help and, in some situations, they feel that the only way to get peace and feel better is by taking their own life. The community is not aware of the resources that are available to adults and youth, as well as for family members of someone with a mental illness. Family members need to be aware of what the process is if you call 911, who to ask for, and what will happen to the person in the crisis. When a student dies by suicide, everyone is quick to blame everyone else. There should be no blame, we as a community need to work together to find a solution.

How to Solve the Problem

• We need to start teaching our youth at a young age about understanding their feelings, knowing empathy, kindness, having a go-to person if they are feeling sad and we must continue this education at every age of their youth. Their thoughts change as they get older, and we need to keep the activities current and interactive. By the time a child starts middle school they should have a better understanding of mental health, understanding it is okay to not feel okay, to not be afraid to ask for help and identify a go-to person that they can trust to talk to. They need to know the resources and peer groups that are available to them, and their parents need to be educated in this also. Parents need to understand how to talk to their child or another youth, know the signs of a mental health crisis, know the resources that are available, how to ask for help and not be ashamed that their child needs help.

For this "problem" and the purpose of the grant proposal, Speak Up: Let's Talk About Mental Health will be providing mental health activities to the curriculum of four youth summer camps in North Pinellas County for the summer of 2024. The students are in classes K-8. We will reach out and coordinate with Union Academy in Tarpon Springs, Cops n' Kids in Tarpon Springs, and the Mattie Williams Neighborhood Family Center in Safety Harbor. I would like to work with at least one more summer camp; Boys and Girls Club, a local church camp or possibly a city recreational camp in Tarpon Springs or Palm Harbor.

Our summer curriculum will include:

- Mental Health Interactive Activities specific to the age groups. These will include art
 projects, gratitude journals, book readings, understanding how the brain works, and
 engaging conversations. We work with the students to embrace their uniqueness as well
 as others' and to understand that by working together more can be accomplished.
- We will offer yoga for youth which will help the students learn how to calm themselves if they are triggered by an event.
- We will offer cardio drumming. Not only is this great exercise, but it also helps with team building.
- We will have a basic financial presentation for the older students. This is another topic not taught in school and can lead to a lot of stress as they get older.
- We will bring in local authors to read their books to the classes and all the students will receive a personalized copy for them to take home.
- We will also create a library or add to an existing one at each center.
- Any other activities or presenters that we feel would be appropriate for the centers and improving mental health for all ages.
- Provide Buddy Benches to the youth centers.
- With any additional funding available we would offer financial scholarships for youth to attend summer camps and sponsor the children that are unable to participate in the field trips because of the cost. They will not feel excluded if they are able to participate in all events.
- We will also meet with the parents and caregivers to talk about how to discuss mental health with their children.

The success of our program will be measured with follow-up visits to the centers to speak with the teachers to learn how the students are interacting with each other and how the overall behavior of the students is. We will also do some activities with the after-school program students and ask how they are applying what they learned as well as some refresher activities.

• We are hoping that The White Family Foundation will share our mission and support us by approving our grant proposal request for \$8,000 so that we can educate and bring awareness to our youth in North Pinellas County about mental health, the resources available and how to help themselves as well as others. With this funding we will be able to successfully offer our programs to approximately 400 youth in our area that attend summer camps.

Financials:

- Balance sheet: included at end of proposal

- **Organizational Budget:** Due to being a new non-profit, our funds are currently distributed as follows:

70% goes directly to the programs held in our community.

15% is allotted for printing and marketing materials.

10% is allotted for miscellaneous expenses.

Our funds continue to grow based on new sponsorships, fundraisers, grants, and individual donations. During 2024, we will develop an organizational budget based on a more consistent pattern of sponsorships, donations, etc.

• Program Budget:

\$8000 starting budget, \$2000 used for each of the four centers.

- \$350 yoga offered every other week at each center (total \$1400)
- \$300 cardio drumming, twice at each center (total \$1200)
- \$300 for four Buddy Benches (total \$1200)
- \$200 to create a library at each of the four centers, average of 20 books for each center, for all age groups (total \$800)
- \$375 for each center to buy supplies for mental health activities, backpacks, books for each student and a reward at the end of the summer (pizza party, etc.) (total \$1500).
- Sponsor the children that are not able to attend the field trips at the camps (total \$600).
- Sponsor other programs that the Directors at the camps have expressed an interest in offering their campers (i.e., gymnastics, dancing, jiu jitsu, etc.) (total \$1300).

TOTAL \$8000 for summer program at four local youth community centers.

The mental health activities and discussions are presented by me, and we also have donations of gratitude journals and activity books from JWB Pinellas. We bring in a trained professional to offer the yoga and meditation as well as the cardio drumming classes. The financial and nutrition programs are provided at no charge. I may also explore the opportunity to bring in Reading with Paws (no fee) and the local authors do not charge for their time.

- Have presented at National and International Conferences speaking about my lived experience, surviving the loss of my son and how to become involved in the Crisis Intervention Team training for law enforcement.
- Have spoken to college students, large employer groups and community gatherings about how we can work together to make an impact.
- Vice-President: Brian Handley
 - On board since May 2022.
 - Lived experience as a sibling of someone with a mental illness and who died by suicide.
 - Being available to talk to others who have a sibling with a mental illness and understanding how that affects them.
- Treasurer: William Handley
 - On board since May 2022
 - Lived experience as the father of someone with a mental illness and who died by suicide.
 - Being available to talk to parents, particularly fathers of someone who has experienced the same loss. Males generally process this grief differently.
- Heidi Lovering: Secretary
 - On board since May 2022
 - Has lived experience as someone with a mental illness and has a successful career and life.
 - Being available to talk to peers who are experiencing some of the same symptoms and feelings as she struggled with.
 - Talented and creative in assisting with unique fundraisers and promoting our organization.
- All Board Members participate in our fundraisers and events. We hold bi-monthly meetings to discuss upcoming events and programs, budgets, and new initiatives to meet our goals.
- We also have committee members that assist us with fundraising events and programs held throughout the community.

Goals for 2023-2024:

- We will be working with PTAs of Pinellas County Schools. I am on the agenda to speak at the first meeting of all PTA presidents at the beginning of the school year.
- We will be forming a "One Voice" committee that will meet quarterly to discuss how we can work together to have an impact on mental illness and suicide preventions in the schools. The committee members will include a parent of a MS or HS student, a PCS Student Services employee, a law enforcement officer, a high school student, a member of a county organization with resources (NAMI-Pinellas, JWB,), and a college student. PCS Student Services have already committed to serving on this committee and are supportive of the idea. The idea being that we should not be placing blame on anyone when a student is in a mental health crisis or dies by suicide. We need to work together and see all viewpoints to find solutions that will decrease the incidents.
- We would like to hold a Youth Mental Health Summit in 2024. We will invite keynote speakers that will address youth mental health, activities, people with lived experiences sharing how they learned to live and thrive with their illness, a celebration of youth, and vendors for resources available in our community. This would become a yearly event.
- We will continue to work with the local youth by engaging them in conversations at after school programs, community sports teams, private and charter schools.
- We will be working with NAMI-Florida to bring the Crisis Intervention Team training course to School Resource Officers, FDLE employees and other law enforcement municipalities that are not able to attend PCSO courses. I will be training other NAMI affiliates how to become involved in this training in their areas. Even though #988 is in place, police officers will still be called for many mental health crises calls and they should be educated on how to interact with that person.
- We will continue to offer mental health programs to the youth summer camps in North Pinellas County. In the summer of 2024, we will increase the number of camps we work with.
- We will be organizing a Third Friday activity for the youth in Safety Harbor and possibly Tarpon Springs. There have been concerns about the youth not having activities to keep them occupied during these events. I have spoken with the youth and they have given me some great ideas about what they would like to do on these Fridays.
- We would like to start working with equine therapy organizations that specialize in helping children with mental health concerns.

Long Term Goals (within the next 2-4 years):

- To offer a weeklong camp for children who have lost someone they knew to suicide. There are no support groups or resources besides individual therapy for a child who has experienced a loss due to suicide. Therapy can be expensive and is not always an option for their family to support. We would like to have a camp that will have therapists available for individual sessions, group sessions, and a variety of exercises that will teach them coping skills and how to work through their grief. Loss to a suicide is very complicated grief and it is difficult for adults to navigate their way through this process. The children who have experienced this loss seemed to be overlooked, which can lead to long-term trauma and difficulty with life in general as they get older. We want to be able to offer a place for them to heal, be around others with the same loss and have professional guidance.
- To purchase a mental health crisis canine(s) for Pinellas County Sheriff's Office. These dogs are trained to be taken on a mental health crisis call with a CIT trained officer and assist with

de-escalating the situation. Pasco County Sheriff's Office now has nine of these canines and they have been proven to make a significant difference when the officers are responding to this type of call.

Closing Paragraph:

I know that we are a new non-profit organization, however I want to assure you that we are making an impact in our community on how mental health, mental illness and suicide is addressed and we will continue to do so. I recently retired early from Pinellas County Schools, so that I could devote myself full-time to our organization. It is crucial for everyone, particularly our youth, to have a clear understanding of what mental health is and how to cope with changes in their mental health as well as someone they may know. We as a community cannot be afraid to talk about these topics. By not talking, we contribute to the stigma of mental illness which leads to more people not asking for help. I may not have the grant writing skills perfected yet, but our board members and volunteers do have the passion, the knowledge, and the capability to make a change. We are fortunate to have the support of many individuals and local businesses that understand the importance of our mission. Our hope is that from the tragedy of losing Scott, we can help others ask for help, receive quality care and give them hope. We do not want anyone to suffer in silence due to an illness that they did not do anything to get and that is an actual illness, just like diabetes, hypertension, cancer, etc. Speak Up: Let's Talk About Mental Health will continue to grow and I appreciate your consideration in supporting us to help our youth as well as our community. 
